- developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- That school is not paying any charges towards using name, motto, logo or any other nonacademic activities to any other institution, organization or body.
- That the school will not open classes under CBSE patten particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- That the school will ensure compliance of all statutory requirements like EPF, ESI and Labor Laws etc. with respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
- 12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
- That the school will not coerce any student/parents to buy books/stationary/uniform from any particular shop.


